SUBJECT: Neosho Police Department Conducts Alcohol Compliance Checks, Reinforces Commitment to Public Safety

The Neosho Police Department announced the results of recent alcohol compliance checks conducted in various establishments throughout Neosho. These checks, aimed at ensuring compliance with state and local laws regarding the sale of alcohol to minors, are part of the department's ongoing efforts to reduce underage drinking and promote public safety.

A total of 30 establishments were selected, with 24 compliance checks completed. Two establishments were found to be in violation of the law by selling alcohol to individuals under the age of 21. As a result, citations for Selling Alcohol to a Minor were issued to the individuals who made the sales.

The Neosho Police Department remains committed to protecting our youth by preventing underage drinking and ensuring that all establishments sell alcohol responsibly and in accordance with the law. We appreciate the cooperation of the many businesses that follow the law and support our efforts to maintain a safe environment.

These compliance checks are one component of a broader initiative to reduce underage drinking, which continues to be a significant public health concern. The department encourages parents and guardians to talk openly with their children about the risks of underage drinking and to monitor their activities.

The Neosho Police Department will continue to conduct compliance checks and other enforcement efforts to promote public safety and uphold the law.
